This letter is a final response to your request for information pursuant to the Freedom of Information Act (FOIA), 5 U.S.C. § 552, dated April 27, 2018 and received in this office on April 30, 2018. Your request was forwarded to the Office of the Secretary and Office of Post-Secondary Education for documents that may be responsive to your request.

You requested the following: All documents constituting or reflecting communications, regardless of the subject matter, between the Department and its employees or representatives, on the one hand, and of ACICS (including its representatives, counsel, and employees).

Available for download via Public Access Link (PAL) are 945 pages of documents responsive to your request. The documents provided are: All documents from the custodians Herman Bounds (and all staff in the OPE Accreditation Group) constituting or reflecting communications, regardless of the subject matter, between the Department and its employees or representatives, on the one hand, and of ACICS (including its representatives, counsel, and employees).

In addition, an interim response dated August 8, 2018 was emailed to you and the ACICS Order of the Secretary Docket No. 16-44-0 (four pages) from the Office of the Secretary.

However, certain information has been withheld according to FOIA exemptions (b)(6), specified below:

• Records or portions of records relating to personal information is exempt pursuant to 5 U.S.C. §552 (b)(6) of the FOIA. Disclosure of this information would constitute a clearly unwarranted invasion of personal privacy.

Provisions of the FOIA allow us to recover the costs pertaining to your request. The Department has concluded that you fall within the category of an all other use requester. However, the Department has provided you with this information at no charge. The Department's release of this information at no cost does not constitute the grant of a fee waiver and does not infer or imply that you will be granted a fee waiver for future requests made under FOIA to the Department. Because we were able to locate and process these documents at minimal costs, they are provided to you at no cost.

You have the right to seek assistance and/or dispute resolution services from the Department's FOIA Public Liaison or the Office of Government Information Services (OGIS). The FOIA Public Liaison

is responsible, among other duties, for assisting in the resolution of FOIA disputes. OGIS, which is outside the Department of Education, offers mediation services to resolve disputes between FOIA requesters and Federal agencies as a non-exclusive alternative to appeals or litigation.
