This letter is a final response to your request dated December 4, 2018 requesting information pursuant to the Freedom of Information Act (FOIA), 5 U.S.C. § 552. Your request was received in the FOIA Service Center (FSC) on December 5, 2018 and was forwarded to the appropriate office within the Department of Education (the Department) for any responsive documents they may have.

You requested the following:

- 1. FSA's Final Audit Determination issued in connection with the OIG's September 2012 Final Audit Report entitled "Colorado Technical University's Administration of Title IV, Higher Education Act Student Financial Assistance Programs" (full citation above); and
- 2. FSA's Final Audit Determination issued in connection with the OIG's September 2017 Final Audit Report entitled "Western Governors University Was Not Eligible to Participate in the Title IV Programs" (full citation above).
